Users can visit the website by registering their details. After that the registration process got over they can enter into the site by logging in with their registered email id and password and after that user can enter into the webapplication.




FIG.2 USER REGISTRATION

## 5.2 ORPHANAGE DETAILS MODULE




FIG.3 ORPHANAGE DETAILS
